


Standard Bins for LC503FBL1-15Q-A3 ($I_F = 20 \text{ mA}$)

All luminous intensity (I_v) and dominant wavelength (λ_D) values shown and specified are at I_F = 20 mA.







- 1. All ranks will be included per delivery; rank ratio will be based on the dice distribution.





FIG.2 REVERSE CURRENT VS. REVERSE VOLTAGE.



WAVELENGTH.




FIG.6 FAR FIELD PATTERN




Mechanical Dimensions


Users should be cautioned not to stare at the light of this LED product. The bright light can damage the eye.
